

- 21-22 Perkins V Post School Survey
  - Post Graduate activity data reported in 21-22 ADVISER
  - Verification Reports (Change School Year to 21-22)
    - Perkins V Post School Survey List
      - Lists the 2022 concentrators who graduated and need to be surveyed
    - Post Graduate Activity
      - List of 2022 graduates surveyed and reported
    - Students Missing Post Graduate Activity
      - A list of 2022 graduates who are not reported
    - Download NSC Data
      - Displays National Student Clearinghouse data



- SPED Post School Outcomes reminder
  - The information collected (exited SPED students) is not shared publicly and only used to survey students on their post-secondary status
  - 21-22 SPED Exiters: Survey sent annually in May
    - Too late to make changes to this data (data pulled end of April)
  - 22-23: Now, view 22-23 data to know who will be surveyed in May 2024
    - SPED exiters from 22-23 school year
    - Ages 14+ (in past years it was 16+)



#### ADVISER Validation (continued)

- Errors/Warnings
  - Focus on errors relating to the following data sets here are a few examples
    - Demographics
      - 716: Student Demographics Record Missing for Student Enrolled in District
      - 743: No Race Reported for Student
    - Enrollment
      - 439: No Current School Enrollment Record for a High School Student Enrolled In the Previous Year
      - 523: Student In Grades K-8 Without Enrollment Record Exit Code Who Do Not Appear In Following School Year
    - Courses
      - 795: High School Course With No Planned Instructional Time Reported (New)
    - Early Childhood
      - 455: PK Grade Students Are Not Reported With Either Early Childhood Program or Special Education Program

ADVISER Validation (continued)

- Errors/Warnings (continued)
  - Focus on errors relating to the following data sets here are a few examples
    - SPED
    - Attendance
      - 735: No Absences Reported at a School
    - Grad Cohort
    - Discipline
      - 736: Discipline Length Missing for Suspension/Expulsion

Reminder: If you can't click through the errors, you may be missing some access – contact your Portal District Admin for additional activation codes

ADVISER Validation (continued)

- Verification Reports
  - List of Verification Reports to review for 22-23 Year End bottom of this page: <a href="https://help.education.ne.gov/knowledge-base/workdays/">https://help.education.ne.gov/knowledge-base/workdays/</a>
  - Reporting Windows
    - Full Year any students enrolled in your district at any time during the school year, even if already exited
    - As of Today students who are enrolled in your district today, can be used for comparing against reports in your SIS
    - As of October 1st students enrolled in membership or SPED programs on 10/1, according to what is currently in ADVISER

ADVISER Validation (continued)

- Verification Reports (continued)
  - Reporting Windows
    - As of October 1st (Locked) students enrolled in membership or SPED programs on 10/1, according to the state accountability data that was locked on 11/1
    - End of Year Available May 1st students enrolled at the end of the school year, according to the state accountability data that will be locked on 7/1
    - End of Year (Locked) Available in July students enrolled at the end of the school year, according to the state accountability data locked on 7/1

Helpful tip: have appropriate staff 'sign off' on each of their associated reports



- District Admin Approval
  - After Errors/Warnings reviewed
  - And Verification Reports 'signed'
  - The Superintendent (or District Admin) will approve the 22-23 Year End collection
    - Instructions: <u>https://cdn.education.ne.gov/wp-content/uploads/2020/09/District-</u> <u>Admin-ADVISER-Approval.pdf</u>
  - Timing: approval will open a few days before audit window closes (June 30)

- Final 22-23 Year End Reminders
  - Focus on students coming back next year (18-21)
    - Who are they?
    - Don't exit their enrollment or SPED records
  - Exiting students from SPED
    - Who are they?
    - Get their exit enrollment and SPED data entered now don't wait for summer
  - Reminder: Run reports for full year attendance data, so ready for fall audit – information isn't updatable when your audit occurs
  - Reminder: Review your exempt student list in Exempt School Report
    - These students need to be verified every year





Staff Reporting

- New Position Assignment Codes
  - 5190 Substitute Teacher (collected through the CDC in previous years)
    - Report Days Worked now
  - 5330 Activities/Athletic Coach (never been collected)
  - Staff Manual: FAQ's Appendix G
- Renamed Position Assignment Code
  - 5160 Instructional Support Paraprofessional
- New errors in NSSRS Validation
  - 589-No Appropriate Certificate for Substitute Teacher
  - 590-No Appropriate Certificate for Activities/Athletics Coach
  - 591-No Days Worked Reported for Substitute Teacher
  - 592-Maximum Days Worked Reported for Substitute Teacher



ADVISER Validation

- NEW: Data Elements
  - Attempt Status An indication of the student's completion status for the associated section; the Fail, Incomplete, and Withdrawn statuses are used to determine which students should not get credit for completing the course section when the section data is used for state and CRDC reporting.
  - Required for grades 9-12 if applicable (if blank, Pass is assumed)

CODE	DESCRIPTION
Pass	The student completed the course (optional)
Fail	The student received a failing grade
Incomplete	The student was marked as Incomplete in the section for any reason
Withdrawn	The student withdrew from the section before the end of the term
Audited	The student audited the course (optional)



- NEW: Data Elements (continued)
  - Instructional Time Planned The planned total number of clock minutes of instruction for this Course Offering.
    - Required for grades 9-12
    - 900 minutes = 1 IU
    - New Warning 795: High School Course with No Planned Instructional Time Reported

- NEW: Data Elements (continued)
  - Behavior The conduct of a student that resulted in a disciplinary action
- UPDATED: Data Elements
  - **Bullying** Districts are only required to report the perpetrator(s) of a discipline incident unless the Behavior is Harassment or Bullying on a specific basis (Behavior codes 105, 106, 107, 108, and 109). Both Perpetrator(s) and Victim(s) should be submitted in that case, for the purpose of CRDC reporting.
  - **Restraint** now collected as part of State Reporting (vs just being for CRDC)

  - Teachers Properly Endorsed Percentage
  - Instructional Time Planned and Attempt Status added to the following Course Reports
    - Courses
    - Course Roster
    - Student Courses
    - Student Grade Details
    - Teacher Courses

ADVISER Validation

- NEW: Data Elements
  - IEP/IFSP Begin Date
    - The effective date of the student's current IEP/IFSP. Typically, this date changes once per year and may or may not be the same as the SPED program record Begin Date field.
  - Optional reporting of additional disabilities within a single SPED record
    - Disability remains the same
    - Adding Disability Order
      - A number indicating the ordering for records where there are multiple disability codes reported. The student's primary disability should be marked as 1, and any additional disabilities reported should be a higher number.

- NEW: Data Elements (continued)
  - Part C to B Transition Delay Reason
    - A reason that a student who has reached their 3rd birthday continues to be served under Part C rather than Part B.

Code Value	Description
1	Parent refused consent
2	Parent chose to remain in Part C
3	Other

ADVISER Validation (continued)

- UPDATED: Data Element
  - Language Instruction
    - Describes the methods used to provide English Language services.
      - 01: Content Classes with Integrated ESL Support or Sheltered Instruction
      - 02: Dual Language or Two-Way Immersion
      - 03: English as a Second Language or English Language Development
      - 04: Heritage Language
      - 05: Structured English Immersion or Newcomer Program
      - 06: Transitional Bilingual or Early-Exit Bilingual Education
      - 07: Other REMOVED


